### JOB PURPOSE:

To be an active member of the Boyd/Malcom research team assisting in the planning and delivery of research activity for a Population Council funded project to perform CMC activities that will advance the regulatory pathway for the next generation of antiretroviral intravaginal ring. This research will build upon the success of the current Dapiring product that is currently marketed for the prevention of HIV.

#### **MAJOR DUTIES:**

- 1. Develop and plan research, and undertake research under supervision within a specific research project or as a member of a research team.
- 2. Design, develop and maintain equipment, and/or experiments in order to obtain reliable data.
- 3. Carry out analyses, critical evaluations, and interpretations using methodologies and other techniques appropriate to area of research.
- 4. Present regular progress reports on research to members of the research group and to external project stakeholders to disseminate and publicise research findings.
- 5. Prepare, often in consultation with supervisor, material for publication in national and international journals and presentations at international conferences.
- 6. Assist grant holder in the preparation of funding proposals and applications to external bodies.
- 7. Carry out routine administrative tasks associated with the research project/s to ensure that project/s are completed on time and within budget. These might include organisation of project meetings and documentation, financial control, risk assessment of research activities.
- 8. Carry out occasional undergraduate supervision, demonstrating or lecturing duties within the post holder's area of expertise and under the direct guidance of a member of academic staff.
- 9. Read academic papers, journals and textbooks to keep abreast of developments in own specialism and related disciplines.

#### **ESSENTIAL CRITERIA:**

- 1. Have or about to obtain\* a PhD in pharmaceutics, drug delivery, or closely related subject; (\*viva examination must be completed).
- 2. Substantial experience to include the following:
  - •Practical experience in manufacturing and testing of polymeric sustained/controlled release drug delivery devices.
  - •Practical experience in performing drug release studies and modelling drug release data.
  - •Practical experience in HPLC analysis.
  - •Practical experience in mechanical characterization of polymeric drug delivery devices.
  - •Evidence of ability to plan and manage research projects.
  - •Previous practical experience in supervising undergraduate research projects.
- 3. Ability to interact with research colleagues and support staff.
- 4. Ability to analyse and communicate effectively.
- Demonstrable intellectual ability. Ability to work as part of a team.

## **DESIRABLE CRITERIA:**

- 1. Practical experience in manufacturing and testing of silicone elastomer or thermoplastic vaginal ring devices.
- 2. Previous practical experience in supervising postgraduate taught (PGT) or research (PGR) students.
- 3. Demonstratable knowledge of contraceptive, HIV prevention, and MPT technologies, particularly in the context of women's health.
